# RELATIVISTIC ENTROPY INEQUALITY

#### Abstract

In this paper we apply the entropy principle to the relativistic version of the differential equations describing a standard fluid flow, that is, the equations for mass, momentum, and a system for the energy matrix. These are the second order equations which have been introduced in [3]. Since the principle also says that the entropy equation is a scalar equation, this implies, as we show, that one has to take a trace in the energy part of the system. Thus one arrives at the relativistic mass-momentum-energy system for the fluid. In the procedure we use the well-known Liu-Müller sum [10] in order to deduce the Gibbs relation and the residual entropy inequality.

## 1 Introduction

It has been a long history for the entropy principle to come up to the essential differential inequality

$$
\begin{equation*}
\sigma:=\partial_{t} \eta+\operatorname{div}_{x} \psi \geq 0 \tag{1.1}
\end{equation*}
$$

in classical coordinates $(t, x), x=\left(x_{1}, \ldots, x_{n}\right)$ where $n=3$ is the physical case. Here $\eta$ is the entropy and $\psi$ the entropy flux, hence $\underline{\eta}=(\eta, \psi)$ are the total entropy quantities. This principle has been successfully applied to the mass-momentum-energy system in many physical examples. The history started $\approx 150$ years ago and one can find this principle in many books, among them Prigogine [12, Chapter III], DeGroot \& Mazur [4, Chapter III], Truesdell \& Noll [14, D.II], Truesdell [13], Ingo Müller [9, Kapitel IV], to mention a few, which were all published in the period 1954-1973. It is part of the entropy principle that the differential equation $\sigma=\partial_{t} \eta+\operatorname{div}_{x} \psi$ is an objective scalar equation, see [2, Sec II.3], by which we mean that for the weak equation

$$
\int\left(\partial_{t} \zeta \cdot \eta+\nabla \zeta \cdot \psi+\zeta \cdot \sigma\right) \mathrm{dL}^{n+1}=0
$$

the test function $\zeta$ is an objective scalar, that is $\zeta \circ Y=\zeta^{*}$, where $Y$ is the observer transformation. This is satisfied, see [2, Sec I.5], if $\eta$ is an objective scalar, that is $\eta \circ Y=\eta^{*}$, and $\psi$ satisfies $\psi \circ Y=\eta^{*} \dot{X}+Q \psi^{*}$.

In the relativistic case one formulates the entropy principle in the form

with 4-dimensional coordinates $y=\left(y_{0}, y_{1}, \ldots, y_{n}\right)$, again $n=3$ in the physical case. As postulate we assume that the weak version

$$

\end{equation*}

is satisfied for objective test functions $\zeta$, that is $\zeta \circ Y=\zeta^{*}$. Here $Y$ is a relativistic observer transformation. This is satisfied, see [2, Sec I.5], if the 4-entropy vector $\underline{\eta}$ satisfies $\underline{\eta} \circ Y=\mathrm{D} Y \underline{\eta}^{*}$, that is, $\underline{\eta}$ is a contravariant vector (see the definition below).

The relativistic case one finds also in sections of the books of Ingo Müller [10] and Müller \& Ruggeri [11]. Here we take advantage of this principle (1.2) and apply it to the relativistic system [3, (10.2)]

which we have developed in [3]. But here we will take it only for $N=2$, that is, we write $\alpha=(k, l)$ with $k, l \geq 0$, and we use a representation which is made for gases and fluids

\end{equation*}

where $\underline{v}$ is the four dimensional fluid velocity, see the definition in [3, 5.2], and with the assumptions (4.3) on $E$ and $\widetilde{\mathbb{Q}}$. It should be said that the right-hand side $g_{k l}$ of this system contains the Coriolis coefficients and of course external or internal forces.

Altogether, this system includes the mass-momentum system and a system describing the energy matrix $E$. The entropy principle for gases and fluids, see section 5 and 6 , forces us to perform a trace of the energy matrix equation in order to have an entropy $\eta$ which is an objective scalar. This method is even new for the classical fluid case. You will find the result in the final theorem s4.7. It contains the statement that the residual inequality $\sigma \geq 0$, that is, the entropy production (4.10) is non-negative. Also as a consequence of the entropy principle there are some important identities. So the entropy $\eta=\widehat{\eta}(\varrho, \varepsilon)$ is a function of the density $\varrho$ and the internal energy

And the system (1.4) is specified by two equations, the mass-momentum and the energy equation, see $4.4(2)$ and 4.5 ,

\end{gathered}
$$

with

\begin{gathered}
\underline{\Pi}:=p\left(\mathrm{PGP}^{\mathrm{T}}\right)-\underline{S}, \\
\widetilde{q}:=\frac{\varrho}{2}\left(\underline{v} \cdot\left(\mathrm{P}^{\mathrm{T}} \mathrm{G}^{-1} \mathrm{P}\right) \underline{v}\right) \mathbf{J}+\underline{v}\left(\mathrm{P}^{\mathrm{T}} \mathrm{G}^{-1} \mathrm{P}\right) \underline{\Pi}+\underline{q},
\end{gathered}
$$

where the inequality restrictions are in the residual inequality $\sigma \geq 0$, see 4.7 for details about the entropy production $\sigma$ and the total entropy $\underline{\eta}$.

Both, the mass-momentum system and the energy equation are reductions of the equations we started with. The statement 4.7 is the entropy principle in the simplest case. More complicated versions one expects in the case that $\eta$ might, for example, depend on gradients as in the classical case, or on other vectorial quantities, because the whole system then is more complicated.

Notation: The definition of a contravariant $M$-tensor $T=\left(T_{k_{1} \cdots k_{M}}\right)_{k_{1}, \ldots, k_{M}}$ is

Here $y=Y\left(y^{*}\right)$ is the observer transformation.

## 2 General moments

The version of moments of order less or equal $N$ is

\end{equation*}

with a tensor $T=\left(T_{\beta}\right)_{\beta \in\{0, \ldots, n\}^{N+1}}$ which has to be symmetric only in the first $N$ components of the multiindex $\beta=\left(\beta_{1}, \ldots, \beta_{M}\right), M:=N+1$, that is, setting $\beta=(\alpha, j)$ as in the equations, $T_{\alpha j}$ and $g_{\alpha}$ are symmetric in the components of $\alpha$. Here $y \in \mathcal{U} \subset \mathbb{R}^{n+1}$ where $y=\left(y_{0}, \ldots, y_{n}\right)$ and $n=3$ in the physical situation. See [3, 10 Higher moments] for more information. System (2.1) is equivalent to the weak version

where the physical type of the system is defined by the fact that the test function $\zeta:=$ $\left(\zeta_{\alpha}\right)_{\alpha}$ is a covariant $N$-tensor, that is it satisfies the transformation rule

This is satisfied, see [2, Chap I §5], if $T$ satisfies the transformation rule

Here $Y: \mathbb{R}^{n+1} \rightarrow \mathbb{R}^{n+1}$ is any observer transformation, that is with determinant 1 . Do to the special rule (2.5) we define the "Coriolis coefficients" $\mathrm{C}_{\alpha}^{\beta}$ by the identity (see [3], for $N=1$ they are identical with the negative Christoffel symbols)

satisfying for all $(\alpha, \bar{\gamma}, \bar{j})$ the transformation rule

& =\sum_{\bar{\alpha}} Y_{\alpha_{1} \bar{\alpha}_{1}} \cdots Y_{\alpha_{N^{\prime}} \bar{\alpha}_{N}} \mathrm{C}_{\bar{\alpha}}^{* \dot{\bar{\gamma}} \bar{j}}+\left(Y_{\alpha_{1} \bar{\gamma}_{1}} \cdots Y_{\alpha_{N} '^{\prime} \bar{\gamma}_{N}}\right)_{{ }_{\prime}^{\prime}} \tag{2.7}
\end{align*}

so that the so-called "force" $\underline{\mathbf{f}}=\left(\underline{\mathbf{f}}_{\alpha}\right)_{\alpha}$ satisfies the transformation rule

$$
\begin{equation*}
\underline{\mathbf{f}}_{\alpha} \circ Y=\sum_{\bar{\alpha}} Y_{\alpha_{1} \bar{\alpha}_{1}} \cdots Y_{\alpha_{N} \bar{\alpha}_{N}} \underline{\underline{\alpha}}_{\bar{\alpha}}^{*} . \tag{2.8}
\end{equation*}

Here, as said above, $Y$ is any observer transformation $Y: \mathbb{R}^{n+1} \rightarrow \mathbb{R}^{n+1}$. With this the system (2.1) reads

\sum_{j \geq 0} \partial_{y_{j}} T_{\alpha j}-\sum_{\beta \in\{0, \ldots, 3\}^{N+1}} \mathrm{C}_{\alpha}^{\beta} T_{\beta}=\underline{\mathbf{f}}_{\alpha} \quad \text { for } \alpha \in\{0, \ldots, n\}^{N} \tag{2.9}
\end{equation*}
$$

were now $T$ and $\underline{\mathbf{f}}$ by (2.4) and (2.8) are contravariant tensors, and the the Coriolis coefficients satisfy (2.7). This is the general form of the system of $N$-moments. In [3, 10 Higher moments] the following reduction has been performed.
2.1 Reduction. If $\boldsymbol{e}$ is the "time vector", the ( $N-1$ )-moments system

is fulfilled for

This gives also a reduction of the Coriolis coefficients.
Proof. Define the test function of the $N$-moments system as

That is, if $\left(\zeta_{\gamma}\right)_{\gamma}$ is a covariant tensor then $\left(\zeta_{\alpha}\right)_{\alpha}$ is an allowed covariant test function since $\boldsymbol{e}$ is a covariant vector. Then

& =\int_{\mathbb{R}^{4}} \sum_{\gamma}\left(\sum_{j} \partial_{y_{j}} \zeta_{\gamma} \sum_{i} \boldsymbol{e}_{i} T_{\gamma i j}+\zeta_{\gamma} \sum_{i}\left(\sum_{j} \partial_{y_{j}} \boldsymbol{e}_{i} \cdot T_{\gamma i j}+\boldsymbol{e}_{i} g_{\gamma i}\right)\right) \mathrm{dL}^{4},

which is the weak reduced equation.
Due to examples we obtain the following form of the tensor $T$.
2.2 Special form of $\boldsymbol{T}$. The usual representation of the tensor $T$ is, see for example [3, 10 Higher moments],

Here the " 4 -velocity" $\underline{v}$ is defined as in [3, 5.2 Velocity], that is, as a contravariant vector $\underline{v}$ satisfying

with the normalization that, with $\boldsymbol{e}$ being the covariant "time vector",

And $\varrho$ is defined as a "spacetime mass density", which is an objective scalar satisfying $\varrho \bigcirc Y=\varrho^{*}$. Then the tensor $T$ satisfies (2.4), if $\widetilde{\Pi}$ is also a contravariant tensor.

Here nothing special about $\widetilde{\Pi}$ is said, see e.g. the form in (4.2).

## 3 Lagrange multipliers

The aim is to derive an entropy inequality. Therefore following Liu \& Müller, see the article [6] and the book [9] or the books [10] or [11], and also [2, III §3], we have to find multipliers $\Lambda_{\alpha}$ for $\alpha \in\{0, \ldots, n\}^{N}$ which satisfy for "all functions" (that means for a larger set $\mathcal{P}^{\prime}$ than the set $\mathcal{P}$ of solutions of (2.1))

\sum_{j \geq 0} \partial_{j} \underline{\eta}_{j}-\sigma=\sum_{\alpha} \Lambda_{\alpha}\left(\sum_{j \geq 0} \partial_{j} T_{\alpha j}-g_{\alpha}\right), \tag{3.1}
\end{equation*}
$$

where $\eta$ is the 4 -entropy and $\sigma$ the entropy production. It is part of the entropy principle that $\bar{\sum}_{j \geq 0} \partial_{j} \underline{\eta}_{j}-\sigma$ is an objective scalar, hence in order to have the equation (3.1) it is necessary to state the following lemma. This lemma and the following is true for all values of $\left(\Lambda_{\alpha}\right)_{\alpha}$.
3.1 Lemma. For the sum

\sum_{\alpha} \Lambda_{\alpha}\left(\sum_{j \geq 0} \partial_{j} T_{\alpha j}-g_{\alpha}\right)

being an objective scalar it is sufficient that $\left(\Lambda_{\alpha}\right)_{\alpha}$ is a covariant $N$-tensor. Remark: Here we make use of (2.6), that is the splitting of $g_{\alpha}$.

Proof. Let $\left(\Lambda_{\alpha}\right)_{\alpha}$ be a covariant $N$-tensor, that is

We use the splitting in (2.6). Since $\left(\underline{\mathbf{f}}_{\alpha}\right)_{\alpha}$ is a contravariant $N$-tensor it follows immediately that

is an objective scalar. By (2.6) it remains to consider

that is, we have to show that

If $\zeta$ is an objective scalar, that is $\zeta \circ Y=\zeta^{*}$ hence $\partial_{j} \zeta^{*}=\sum_{j} Y_{j^{\prime} j}\left(\partial_{j} \zeta\right) \circ Y$, with compact support then

& -\int \zeta \sum_{\alpha} \Lambda_{\alpha} h_{\alpha} \mathrm{dL}^{4}=\int \sum_{\alpha}\left(\sum_{j} \partial_{j}\left(\zeta \Lambda_{\alpha}\right) T_{\alpha j}+\zeta \sum_{\beta} \Lambda_{\alpha} \mathrm{C}_{\alpha}^{\beta} T_{\beta}\right) \mathrm{dL}^{4} \\
& =\int\left(\sum_{j} \partial_{j} \zeta \cdot \sum_{\alpha} \Lambda_{\alpha} T_{\alpha j}+\zeta\left(\sum_{\alpha j} \partial_{j} \Lambda_{\alpha} \cdot T_{\alpha j}+\sum_{\alpha \beta} \Lambda_{\alpha} \mathrm{C}_{\alpha}^{\beta} T_{\beta}\right)\right) \mathrm{dL}^{4} .
\end{aligned}
$$

First let us treat the last term

\sum_{\alpha j} \partial_{j} \Lambda_{\alpha} \cdot T_{\alpha j}+\sum_{\alpha \beta} \Lambda_{\alpha} \mathrm{C}_{\alpha}^{\beta} T_{\beta} .
$$

Since $\left(\Lambda_{\alpha}\right)_{\alpha}$ is a covariant $N$-tensor, we compute for the derivatives

& \quad+\sum_{\alpha j} Y_{\alpha_{1}{ }^{\prime} \bar{\alpha}_{1}} \cdots Y_{\alpha_{N}{ }^{\prime} \bar{\alpha}_{N}} Y_{j^{\prime}{ }_{j}} \partial_{j} \Lambda_{\alpha} \circ Y .
\end{aligned}
$$

Now, using (2.7) for the Coriolis coefficients,

& \sum_{\bar{\alpha} \bar{\gamma} \bar{j}} \Lambda_{\bar{\alpha}}^{*} \mathrm{C}_{\bar{\alpha}}^{* \bar{\gamma} \bar{\gamma}} T_{\bar{\gamma} \bar{j}}^{*}=\sum_{\alpha \bar{\alpha} \bar{\gamma} \bar{j}} \Lambda_{\alpha} \circ Y Y_{\alpha_{1}{ }^{\prime} \bar{\alpha}_{1}} \cdots Y_{\alpha_{N}{ }^{\prime} \bar{\alpha}_{N}} \mathrm{C}_{\bar{\alpha}}^{* \bar{\gamma} \bar{\gamma}} T_{\bar{\gamma} \bar{j}}^{*} \\

on single vectors $e_{i}(y), i \geq 1$ (as for example the space directions of crystals or the director of liquid crystals). But we are allowed to use these vectors in proofs. In doing so we introduce values $\left(\lambda_{\gamma}\right)_{\gamma}$ :

by writing the multiindex $\alpha=(k, l)$ for $k, l \geq 0$, and where all quantities are symmetric in $k$ and $l$. The system (4.1) has by definition covariant test functions, and this is satisfied if $T$, $\mathbf{f}$, and C satisfy the transformation rules which we have stated in (2.4), (2.8), and (2.7). We shall consider a simple fluid which is defined by the following representation of the tensor components $T_{k l j}$ for $k, l, j \geq 0$

The usage of the time vector $\boldsymbol{e}$ says that the "time component" of $E$ is zero and that $\widetilde{\mathrm{Q}}$ has no "time derivative". The system (4.1) therefore can be considered as the mass-momentum-energymatrix system.

In 2.1 we have defined a reduced system of (4.1) via the covariant vector $\boldsymbol{e}$. This reduced system is the mass-momentum system

This is a general lemma, that is, it holds without assumption (4.2). With this assumption we perform in the next sections 5 and 6 the entropy principle to system (4.1) and the outcome will be that the physical system we derive finally will consist of

- the reduced mass-momentum system (4.4),
- a trace of the remaining system, which will be the operation $\mathrm{P}^{\mathrm{T}} \mathrm{G}^{-1} \mathrm{P}$.

Here the map P is defined in the following lemma and it is important that it depends only on G and $\boldsymbol{e}$.
4.2 Lemma. We define a linear projection $\mathrm{P}: \mathbb{R}^{4} \rightarrow W:=\{e\}^{\perp}$ by

where in analogy to section 6 the "internal energy" $\varepsilon$ is

\end{aligned}

Here the entropy and entropy 4-flux are

Proof. The proof of this theorem is contained in section 5 and 6 . The splitting of the mass-momentum-energymatrix equation into mass-momentum and energy equation is contained in the statements 4.4 to 4.6 .

The pressure tensor $\underline{\Pi}$ is by $4.4(2)$

In the case of a gas $\underline{\Pi}=p \mathrm{PGP}^{\mathrm{T}}$ and $\underline{S}=0$, therefore the first term of the entropy production vanishes. For fluids the stress tensor $\underline{S}$ has to be chosen so that the entropy production is non-negative. This term in the entropy production is

## 5 Evaluation of the Liu \& Müller sum

In this section we consider the relativistic moments of up to second order, that is $N=2$ in (2.1) and $\alpha=(k, l)$,

where we have set $n=3$ (the physical case). We consider fluid equations, therefore

The first step in exploiting the entropy principle is to multiply the differential operators $\sum_{j \geq 0} \partial_{y_{j}} T_{\alpha j}-g_{\alpha}$ by certain factors, which Liu \& Müller call Lagrange multipliers $\left(\Lambda_{\alpha}\right)_{\alpha}$, see section 3, and then sum up these expressions to get

## 6 Entropy as objective scalar

Here we deal with system (5.1) and the assumption (5.2) and (5.3). In this situation we have derived in the previous section, that for solutions of (5.1)

where the entropy 4 -flux $\eta$ satisfies (5.11) and the entropy production $\sigma$ satisfies (5.12). And the entropy principle $\sigma \geq 0$ is required. It is also a postulate of the entropy principle that the equation (6.1) has to be a scalar differential equation, which is satisfied if $\underline{\eta}$ is a contravariant vector and $\sigma$ an objective scalar. Now, the first term on the right-hand side of $\eta$ in (5.11) is $\eta \underline{v}$ where $\underline{v}$ is a contravariant vector, therefore, if $\eta$ is an objective scalar this term is a contravariant vector. Remember that in (5.11) we have made a constitutive relation for $\eta$ depending on $\varrho, v_{k}^{\prime}=e_{k}^{\prime} \bullet \underline{v}$ and $E_{k l}^{\prime}$. These quantities are all
objective scalars, but they depend on single basis vectors $e_{i}^{\prime}$ for $i \geq 1$. This would be a non-isotropic behaviour if $\eta$ depends really on one of these vectors. Such a dependence one would not allow for a simple fluid. Therefore we come to the conclusion that $\eta$ depends only on $\varrho$ and the trace of $E^{\prime}$, that is

which is the "internal energy" and which of course is an objective scalar as the sum of the objective scalars $E_{k k}^{\prime}$. It has been proved in 4.2 that $\varepsilon$ is depending on $E=\left(E_{k l}\right)_{k, l \geq 0}$, the energy matrix in definition (5.2), and apart from this only on G and $\boldsymbol{e}$, that is

\end{equation*}
$$

Consequently we have for the function $\widetilde{\eta}$ in (5.11)

$$
\widetilde{\eta}\left(\varrho,\left(v_{k}^{\prime}\right)_{k \geq 1},\left(E_{k l}^{\prime}\right)_{k, l \geq 1}\right)=\eta=\widehat{\eta}\left(\varrho, \frac{1}{2} \sum_{k \geq 1} E_{k k}^{\prime}\right),
$$

and it follows from (5.10) that

$$
\begin{aligned}
& \lambda^{\varrho}=\widetilde{\eta}_{\varrho}{ }_{\varrho}=\widehat{\eta}^{\prime} \varrho, \quad \lambda_{k}^{v}=\frac{1}{\varrho} \widetilde{\eta}_{\prime^{\prime} v_{k}^{\prime}}=0, \\
& \lambda_{k l}^{e}=\widetilde{\eta}_{'_{k l}^{\prime}}=\frac{\lambda^{e}}{2} \delta_{k, l}, \quad \lambda^{e}:=\widehat{\eta}_{\varepsilon} .
\end{aligned}
$$

With these identities and

$$
\underline{q}_{j}:=\frac{1}{2} \sum_{k \geq 1} \underline{\mathrm{Q}}_{k k j}^{\prime}, \quad \mathbf{r}^{e}:=\frac{1}{2} \sum_{k \geq 1} \mathbf{r}_{k k}^{e}
$$

the formula (5.11) for the entropy equation becomes

$$
\begin{equation*}
\underline{\eta}_{j}=\eta \underline{v}_{j}+\widehat{\eta}_{\varrho} \underline{\mathbf{J}_{j}}+\widehat{\eta}_{\prime} \varepsilon \underline{q}_{j}, \quad e \bullet \underline{\eta}=\eta, \tag{6.4}
\end{equation*}
$$

where the last equation follows from the assumption on $\widetilde{Q}$ in (5.3). Besides this the entropy production (5.12) becomes

$$
\begin{array}{r}
\sigma=-\sum_{j \geq 0, k \geq 1} \partial_{j} v_{k}^{\prime}\left(\left(\widehat{\eta}_{\varrho} \varrho+\widehat{\eta}_{\prime_{\varepsilon}} \varepsilon-\eta\right) e_{k j}+\widehat{\eta}_{\prime_{\varepsilon}} \underline{\Pi}_{k j}^{\prime}\right) \\
+\sum_{j \geq 0} \partial_{j} \widehat{\eta}_{\varrho \varrho} \cdot \underline{\mathbf{J}}_{j}+\sum_{j \geq 0} \partial_{j} \hat{\eta}_{\eta_{\varepsilon}} \cdot \underline{q}_{j} \\
+\widehat{\eta}_{\prime} \mathbf{r}^{\varrho}+\widehat{\eta}^{\prime} \cdot \mathbf{r}^{e} .
\end{array}
$$

To proceed further let us assume that, in analogy to the classical case,

$$
\begin{equation*}
\frac{1}{\theta}:=\widehat{\eta}_{\varepsilon}(\varrho, \varepsilon)>0, \quad \frac{\mu}{\theta}:=\widehat{\eta}_{\varrho}(\varrho, \varepsilon) . \tag{6.5}
\end{equation*}
$$

Here $\theta$ is the "absolute temperature" and $\mu$ the "chemical potential". We define the preliminary version $\left(\underline{S}_{k j}^{\prime}\right)_{j \geq 0, k \geq 1}$ of the stress tensor by

$$
\underline{S}_{k j}^{\prime}:=\theta\left(\left(\eta-\widehat{\eta}_{\varrho} \varrho-\widehat{\eta}_{{ }^{\prime} \varepsilon} \varepsilon\right) e_{k j}-\widehat{\eta}_{{ }^{\prime}} \underline{\Pi}_{k j}^{\prime}\right)=(\theta \eta-\mu \varrho-\varepsilon) e_{k j}-\underline{\Pi}_{k j}^{\prime}
$$

for $k \geq 1$, so that one gets for the entropy production the final version

$$
\begin{array}{r}
0 \leq \sigma=\widehat{\eta}_{\boldsymbol{\prime}} \sum_{j \geq 0, k \geq 1} \partial_{j} v_{k}^{\prime} \underline{S}_{k j}^{\prime}+\sum_{j \geq 0} \partial_{j} \widehat{\eta}_{\prime} \cdot \underline{\mathbf{J}}_{j}+\sum_{j \geq 0} \partial_{j} \widehat{\eta}_{\eta_{\varepsilon}} \cdot \underline{q}_{j}  \tag{6.6}\\
+\widehat{\eta}_{\prime}^{\prime} \mathbf{r}^{\varrho}+\widehat{\eta}_{\varepsilon} \cdot \mathbf{r}^{e}
\end{array}
$$

where $\sigma \geq 0$ by the entropy principle. If we now define the "pressure" $p$ by

$$
\begin{equation*}
p:=\theta \eta-\mu \varrho-\varepsilon, \tag{6.7}
\end{equation*}
$$

which is Gibbs relation, the above definition takes the common form

$$
\begin{equation*}
\underline{\Pi}_{k j}^{\prime}=p e_{k j}-\underline{S}_{k j}^{\prime} \quad \text { for } k \geq 1 \tag{6.8}
\end{equation*}
$$

We have to write this in terms of the reduced mass-momentum system (4.4)

$$
\begin{gather*}
\sum_{j \geq 0} \partial_{y_{j}} T_{k j}=g_{k} \quad \text { for } k \geq 0, \\
T_{k j}:=\sum_{l \geq 0} e_{l} T_{k l j}=\varrho \underline{v}_{k} \underline{v}_{j}+\widetilde{\Pi}_{k j}, \quad \widetilde{\Pi}_{k j}:=\sum_{l \geq 0} e_{l} \widetilde{\mathrm{Q}}_{k l j} . \tag{6.9}
\end{gather*}
$$

Now, by (5.6), for $k \geq 0$

$$
\widetilde{\mathrm{Q}}_{k 0 j}^{\prime}=\sum_{\bar{k}, \bar{l} \geq 0} e_{k \bar{k}}^{\prime} e_{0 \bar{l}}^{\prime} \widetilde{\mathrm{Q}}_{\bar{k} \bar{l} j}=\sum_{\bar{k} \geq 0} e_{k \bar{k}}^{\prime} \widetilde{\Pi}_{\bar{k} j}
$$

or, by renaming $k$ as $\bar{k}$ and vice versa,

$$
\widetilde{\mathrm{Q}}_{\bar{k} 0 j}^{\prime}=\sum_{k \geq 0} e_{\bar{k} k}^{\prime} \widetilde{\Pi}_{k j}
$$

hence for $k \geq 0$, making use of 3.5 ,

$$
\begin{aligned}
& \widetilde{\Pi}_{k j}=\sum_{\bar{k} \geq 0} e_{\bar{k} k} \widetilde{\mathrm{Q}}_{\bar{k} 0 j}^{\prime}=e_{0 k} \underline{\mathbf{J}}_{j}+\sum_{i \geq 1} e_{i k} \widetilde{\Pi}_{i j}^{\prime} \quad(\text { using (5.6)) } \\
& =e_{0 k} \underline{\mathbf{J}}_{j}+\sum_{i \geq 1} e_{i k}\left(v_{i}^{\prime} \underline{\mathbf{J}}_{j}+\underline{\Pi}_{i j}^{\prime}\right) \quad(\text { using } \\
& =\left(e_{0 k}+\sum_{i \geq 1} e_{i k} v_{i}^{\prime}\right) \underline{\mathbf{J}}_{j}+\sum_{i \geq 1} e_{i k} \underline{\Pi}_{i j}^{\prime}=\underline{v}_{k} \underline{\mathbf{J}}_{j}+\sum_{i \geq 1} e_{i k} \underline{\Pi}_{i j}^{\prime} .
\end{aligned}
$$

Therefore, if we define for $k \geq 0$ the "pressure tensor" and the "stress tensor" by

$$
\begin{equation*}
\underline{\Pi}_{k j}:=\sum_{i \geq 1} e_{i k} \underline{\Pi}_{i j}^{\prime} \quad \text { and } \quad \underline{S}_{k j}:=\sum_{i \geq 1} e_{i k} \underline{S}_{i j}^{\prime}, \tag{6.10}
\end{equation*}
$$

we have shown

$$
\begin{equation*}
\widetilde{\Pi}_{k j}=\underline{v}_{k} \underline{\mathbf{J}}_{j}+\underline{\Pi}_{k j} \text { for } k \geq 0, \tag{6.11}
\end{equation*}
$$

and the identity (6.8) becomes

$$
\begin{aligned}
& \underline{\Pi}_{k j}:=\sum_{i \geq 1} e_{i k} \underline{\Pi}_{i j}^{\prime}=\sum_{i \geq 1} e_{i k}\left(p e_{i j}-\underline{S}_{i j}^{\prime}\right) \\
& =p \sum_{i \geq 1} e_{i k} e_{i j}-\underline{S}_{k j}=p\left(\mathrm{PGP}^{\mathrm{T}}\right)_{k j}-\underline{S}_{k j} \quad \text { (using 4.2(2)), }
\end{aligned}
$$

that is, the well known formula

$$
\begin{equation*}
\underline{\Pi}=p \mathrm{PGP}^{\mathrm{T}}-\underline{S} . \tag{6.12}
\end{equation*}
$$

This shows 4.4(2), and therefore the statements about the reduced mass-momentum system are proved. We come back to the entropy production $\sigma$ in (6.6), which is not so final since it contains the term

$$
\sum_{j \geq 0, k \geq 1} \partial_{j} v_{k}^{\prime} \underline{S}_{k j}^{\prime}=\sum_{j \geq 0}\left(\sum_{i \geq 1} \partial_{j} v_{i}^{\prime} \underline{S}_{i j}^{\prime}\right)
$$

depending on $\underline{S}^{\prime}=\left(\underline{S}_{i j}^{\prime}\right)_{i \geq 1, j \geq 0}$ and not on the stress tensor $\underline{S}=\left(\underline{S}_{k j}\right)_{k, j \geq 0}$. Now, we get from the definition (6.10)

$$
\sum_{k \geq 0} e_{i k}^{\prime} \underline{S}_{k j}=\sum_{i \geq 1} \sum_{k \geq 0} e_{i k}^{\prime} e_{\bar{i} k} \underline{S}_{i j}^{\prime}=\sum_{i \geq 1} \delta_{i, \bar{i}} \underline{S}_{\bar{i} j}^{\prime}=\underline{S}_{i j}^{\prime}
$$

and thus

$$
\begin{array}{r}
\sum_{j \geq 0}\left(\sum_{i \geq 1} \partial_{j} v_{i}^{\prime} \underline{S}_{i j}^{\prime}\right)=\sum_{k, j \geq 0}\left(\sum_{i \geq 1} e_{i k}^{\prime} \partial_{j} v_{i}^{\prime}\right) \underline{S}_{k j} \\
=\sum_{k, j \geq 0}\left(\sum_{i \geq 1} e_{i k}^{\prime} \partial_{j}\left(e_{i}^{\prime} \bullet \underline{v}\right)\right) \underline{S}_{k j} . \tag{6.13}
\end{array}
$$

That this is the generalization of the term in the classical case is shown in the next session.

## 7 Constitutive equation for fluids

We deal with the term (6.13) for the stress tensor $\underline{S}=\left(\underline{S}_{k j}\right)_{k, j \geq 0}$

$$
\begin{equation*}
\sum_{k, j \geq 0}\left(\sum_{i \geq 1} e_{i k}^{\prime} \partial_{j}\left(e_{i}^{\prime} \bullet \underline{v}\right)\right) \underline{S}_{k j} . \tag{7.1}
\end{equation*}
$$

which is part of the entropy inequality $\sigma \geq 0$ in 4.7 . We show that this expression converges as $\mathrm{c} \rightarrow \infty$ to the well known term of the Navier-Stokes limit. By this limit we mean that $e_{k}^{\prime} \rightarrow \bar{e}_{k}^{\prime}$ and $e_{k} \rightarrow \bar{e}_{k}$ as $\mathrm{c} \rightarrow \infty$, where the limit basis are given as usual:
7.1 Limit basis. We obtain in the standard case the limits

$$
\bar{e}_{0}^{\prime}=\left[\begin{array}{l}
1 \\
0
\end{array}\right], \quad \bar{e}_{0}=\left[\begin{array}{l}
1 \\
\mathbf{V}
\end{array}\right], \quad \bar{e}_{i}=\left[\begin{array}{c}
0 \\
\mathbf{Q e} \mathbf{e}_{i}
\end{array}\right], \quad \bar{e}_{i}^{\prime}=\left[\begin{array}{c}
-\mathbf{V} \cdot \mathbf{Q} \mathbf{e}_{i} \\
\mathbf{Q e}
\end{array}\right] \quad \text { for } i \geq 1
$$

where $\mathrm{D}_{x} \mathbf{V}$ is antisymmetric and $\mathbf{Q}$ depends only on $t$.
Proof. We consider the standard case, that is, we assume that $\left|\bar{e}_{0}^{\prime}\right|=1$. Then

$$
\boldsymbol{e}=e_{0}^{\prime} \rightarrow \overline{\boldsymbol{e}}=\bar{e}_{0}^{\prime}=\left[\begin{array}{l}
1 \\
0
\end{array}\right] \quad \text { with } \quad \boldsymbol{W}=\left\{e_{0}^{\prime}\right\}^{\perp} \rightarrow\left\{\bar{e}_{0}^{\prime}\right\}^{\perp}=: \overline{\boldsymbol{W}},
$$

which implies, since $\bar{e}_{0}^{\prime} \bullet \bar{e}_{0}=1$, that

$$
e_{0} \rightarrow \bar{e}_{0}=\left[\begin{array}{c}
1 \\
\mathbf{V}
\end{array}\right]=: \underline{\mathbf{V}}
$$

which is the definition of the vector $\mathbf{V}$. The elements $\left\{\bar{e}_{i} ; i \geq 1\right\}$ are an orthonormal set of $\boldsymbol{W}$, that is

$$
\bar{e}_{i}=\left[\begin{array}{c}
0 \\
\mathbf{Q e}_{i}
\end{array}\right] \text { for } i \geq 1
$$

which is the definition of the orthonormal matrix $\mathbf{Q}$. Then the representation of the elements $\bar{e}_{i}^{\prime}$ follow easily. Now with $Y$ being a Newton transformation, $\mathbf{Q}$ satisfies the transformation rule

$$
\left[\begin{array}{c}
0 \\
\mathbf{Q} \circ Y \mathbf{e}_{i}
\end{array}\right]=\bar{e}_{i} \circ Y=\mathrm{D} Y \bar{e}_{i}^{*}=\left[\begin{array}{cc}
1 & 0 \\
\dot{X} & Q
\end{array}\right]\left[\begin{array}{c}
0 \\
\mathbf{Q}^{*} \mathbf{e}_{i}
\end{array}\right]=\left[\begin{array}{c}
0 \\
Q \mathbf{Q}^{*} \mathbf{e}_{i}
\end{array}\right]
$$

that is $\mathbf{Q} \circ Y=Q \mathbf{Q}^{*}$. Hence if $\mathbf{Q}^{*}$ is the Identity for at least one ${ }^{*}$-observer, then $\mathbf{Q} \circ Y$ is a function of $t^{*}$ only and so $\mathbf{Q}$ is independent of $x$. Similarly, $\mathbf{V}$ satifies the transformation rule

$$
\left[\begin{array}{c}
1 \\
\mathbf{V} \circ Y
\end{array}\right]=\bar{e}_{0} \circ Y=\mathrm{D} Y \bar{e}_{0}^{*}=\left[\begin{array}{cc}
1 & 0 \\
\dot{X} & Q
\end{array}\right]\left[\begin{array}{c}
1 \\
\mathbf{V}^{*}
\end{array}\right]=\left[\begin{array}{c}
1 \\
\dot{X}+Q \mathbf{V}^{*}
\end{array}\right]
$$

that is $\mathbf{V} \circ Y=\dot{X}+Q \mathbf{V}^{*}$, and therefore

$$
\sum_{j \geq 1} Q_{j \bar{j}}\left(\partial_{x_{j}} \mathbf{V}_{i}\right) \circ Y=\partial_{x_{\bar{j}}^{*}}\left(\mathbf{V}_{i} \circ Y\right)=\dot{Q}_{i \bar{j}}+\sum_{\bar{i} \geq 1} Q_{i \bar{i}} \partial_{x_{\bar{j}}^{*}} \mathbf{V}_{\bar{i}}^{*},
$$

hence

$$
\left(\partial_{x_{j}} \mathbf{V}_{i}\right) \circ Y=\left(\dot{Q} Q^{\mathrm{T}}\right)_{i j}+\sum_{\bar{i}, \bar{j} \geq 1} Q_{i \bar{i}} Q_{j \bar{j}} \partial_{x_{\bar{j}}^{*}} \mathbf{V}_{\bar{i}}^{*}
$$

It follows that if $\mathbf{V}^{*}$ is zero for at least one *-observer, then $\left(\partial_{x_{j}} \mathbf{V}_{i}\right)_{i j}$ is antisymmetric.

Since

$$
\sum_{k \geq 0} e_{0 k}^{\prime} \underline{S}_{k j}=0, \quad \sum_{j \geq 0} e_{0 j}^{\prime} \underline{S}_{k j}=0,
$$

we have also in the classical limit

$$
0=\sum_{k \geq 0} \bar{e}_{0 k}^{\prime} \underline{S}_{k j}=\underline{S}_{0 j}, \quad 0=\sum_{j \geq 0} \bar{e}_{0 j}^{\prime} \underline{S}_{k j}=\underline{S}_{k 0},
$$

therefore

$$
\underline{S}=\left[\begin{array}{ll}
0 & 0 \\
0 & S
\end{array}\right] .
$$

Having this in mind we compute, since $\underline{v}=(1, v)$ and

$$
\left[\begin{array}{c}
-\mathbf{V} \cdot \mathbf{Q e}_{i} \\
\mathbf{Q e}_{i}
\end{array}\right] \cdot \underline{v}=(v-\mathbf{V}) \cdot \mathbf{Q} \mathbf{e}_{i}=\left(\mathbf{Q}^{\mathrm{T}}(v-\mathbf{V})\right)_{i}
$$

and since $\mathbf{Q}$ depends only on $t$,

$$
\begin{aligned}
& \sum_{k, j \geq 0}\left(\sum_{i \geq 1} e_{i k}^{\prime} \partial_{j}\left(e_{i}^{\prime} \cdot \underline{v}\right)\right) \underline{S}_{k j} \longrightarrow \sum_{k, j \geq 0}\left(\sum_{i \geq 1} \bar{e}_{i k}^{\prime} \partial_{j}\left(\bar{e}_{i}^{\prime} \cdot \underline{v}\right)\right) \underline{S}_{k j} \\
& =\left(\sum_{i \geq 1}\left[\begin{array}{c}
-\mathbf{V} \cdot \mathbf{Q e}_{i} \\
\mathbf{Q e}_{i}
\end{array}\right] \otimes \underline{\nabla}\left(\left[\begin{array}{c}
-\mathbf{V} \cdot \mathbf{Q} \mathbf{e}_{i} \\
\mathbf{Q e}_{i}
\end{array}\right] \cdot \underline{v}\right)\right): \underline{S} \\
& =\left(\sum_{i \geq 1}\left[\begin{array}{c}
-\mathbf{V} \cdot \mathbf{Q e}_{i} \\
\mathbf{Q e}_{i}
\end{array}\right] \otimes \underline{\nabla}\left(\left(\mathbf{Q}^{\mathrm{T}}(v-\mathbf{V})\right)_{i}\right)\right): \underline{S} \\
& =\left(\sum_{i \geq 1}\left(\mathbf{Q e}_{i}\right) \otimes \nabla\left(\left(\mathbf{Q}^{\mathrm{T}}(v-\mathbf{V})\right)_{i}\right)\right): S \\
& =\sum_{k, j \geq 1} \sum_{i \geq 1}\left(\mathbf{Q e}_{i}\right)_{k} \partial_{x_{j}}\left(\left(\mathbf{Q}^{\mathrm{T}}(v-\mathbf{V})\right)_{i} S_{k j}\right. \\
& =\sum_{k, j \geq 1} \sum_{i \geq 1} \mathbf{Q}_{k i} \partial_{x_{j}}\left(\sum_{l \geq 1} \mathbf{Q}_{l i}(v-\mathbf{V})_{l}\right) S_{k j} \\
& =\sum_{k, j \geq 1} \sum_{l \geq 1}\left(\sum_{i \geq 1} \mathbf{Q}_{k i} \mathbf{Q}_{l i}\right) \partial_{x_{j}}(v-\mathbf{V})_{l} \cdot S_{k j}=\sum_{k, j \geq 1} \partial_{x_{j}}(v-\mathbf{V})_{k} \cdot S_{k j} \\
& =\sum_{k, j \geq 1}\left(\partial_{x_{j}} v_{k}-\partial_{x_{j}} \mathbf{V}_{k}\right) S_{k j}=\sum_{k, j \geq 1} \partial_{x_{j}} v_{k} \cdot S_{k j},
\end{aligned}
$$

if $S$ is symmetric. This is true since $\left(\partial_{x_{j}} \mathbf{V}_{k}\right)_{j k}$ is antisymmetric.
